6. **Street Closing Application from Kyle Johnson and David Bradway for Muncie Bike Fest:** Kyle requested approval to close Mulberry Street from the round-a-bout downtown north to Adams Street, close Adams Street from Jefferson to Liberty, close Franklin Street from Adams to Charles, close Charles Street from Liberty to Jefferson, High Street from Jackson to downtown round-a-about and Walnut Street from Jackson to downtown round-a-about on August 14, 2016 from 6:00 a.m. to 9:00 p.m. for the USA Cycling Sanctioned Bicycle Race sponsored by the City of Muncie. There will be a total five races lasting anywhere from 30 minutes to one hour. At the end of the bike races there will be a Corporate Challenge Race. Approval has been given the Steve Stewart, Muncie Chief of Police, Eddie Bell Muncie Fire Chief and Vickie Veach, Downtown Redevelopment. Roger Overbey moved to approve Muncie Bike Fest as presented. Bobbie Clemens provided the second. Motion passed by voice vote.
7. **Harvey Wright, Superintendent Muncie Parks Department presenting Contract by and between Scarrette Pyrotechnics LLC and the City of Muncie:** Harvey reported that he checked into finding a pyrotechnics company for fireworks display at Prairie Creek Reservoir. 


