



AN ORDINANCE OF THE CITY OF MUNCIE AUTHORIZING THE TRANSFER OF FUNDS FROM THE ADULT PROBATION SERVICES FEE ACCOUNT

WHEREAS, The City of Muncie has, pursuant to Indiana Code 35-38-2-1, collected user fees from individuals placed on probation;

WHEREAS, those funds have been placed in a restricted account specifically created to hold said probation user fees;

WHEREAS, Pursuant to Indiana Code 35-38-2-1(g), the fiscal body of the city shall appropriate money from the adult probation services fund to the city court for the court's use in providing probation services to adults or for the court's use for other purposes as may be appropriated by the fiscal body;

WHEREAS, The Muncie City Court desires to transfer the amount of \$30,508.92 to several accounts holding funds for the 2016 salary and benefits for the Muncie City Court Probation Officer:

WHEREAS, A local ordinance is required to authorize such a transfer;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL FOR THE CITY OF MUNCIE, INDIANA:

- Section 1: The amount of \$30,508.92 be transferred from Account Number 268-08-439071, and allocated as follows:
- a. \$29,989.79 to Account Number 101-08-411120 (Court Secretary)
 - b. \$519.13 to Account Number 101-08-411031 (Probation Officer Salary)
- Section 2: The Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor of the City of Muncie.
