ORDINANCE 43-19

AN ORDINANCE AMENDING CHAPTER 80, SCHEDULE I, ONE WAY STREETS AND ALLEYS, OF THE CODE OF ORDINANCES OF THE CITY OF MUNCIE, INDIANA

WHEREAS, Chapter 80, Schedule I of Muncie City Code governs One Way Streets and Alleys in the City of Muncie, and,

WHEREAS, due to certain conditions in the Washington Street area it is beneficial that the City amend sections of Washington St. as a One Way street in that area,

NOW THEREFORE BE IT ORDAINED, by the Common Council of the City of Muncie, Indiana, as follows:

- Chapter 80, Schedule I, One Way Streets and Alleys, of the Code of Ordinances of the City of Muncie, shall be amended to delete as follows:

Washington St.	High St. and Ohio Ave	East	
Washington St.	Liberty St. and Madison St.	East	

- Chapter 80, Schedule I, One Way Streets and Alleys, of the Code of Ordinances of the City of Muncie , shall be amended to add as follows:

<i>Street</i>	<i>Between</i>	<i>Direction</i>	<i>Ord. No</i>
Washington St.	Monroe St. and Ohio Ave	East	

- Any previous ordinances in conflict herewith are hereby repealed.
- This ordinance shall be in effect from and after its passage by the Common Council, signature of the mayor or override of any veto.
