

ORDINANCE NO. 44-19



AN AMENDMENT TO THE ORDINANCE OF THE CITY OF MUNCIE, INDIANA  
ESTABLISHING AND DESIGNATING A FEE SCHEDULE FOR THE INTERLOCAL  
AGREEMENT WITH CENTER TOWNSHIP FOR FIRE PROTECTION SERVICES

WHEREAS, The Council approved Amendments to the Interlocal Agreement for Fire Protection with Center Township in Resolution 10-13 and the Establishment and Designation Account for Deposit of Funds for Interlocal Agreement with Center Township for Fire Protection in Ordinance 22-13, and,

WHEREAS, it is now necessary to designate a fee schedule for the collection of funds from the Agreement,

**NOW THEREFORE BE IT ORDAINED**, by the Common Council of the City of Muncie, Indiana, as follows:

1. There is hereby established the fee schedule for collection of user fees as set out by Delaware County EMS Ordinance of Fee Schedule, Ordinance 2014-024, which currently is being used by all ambulance providers when billing citizens within the City of Muncie for the use of these services. Such funds collected shall be deposited and used in accordance with the City of Muncie Resolution 10-13 and City of Muncie Ordinance 22-13.
2. This ordinance shall be in effect from and after its passage by the Common Council, signature of the mayor or override of any veto.
