

MUNCIE COMMON COUNCIL ORDINANCE NO. 48-19

AN ADDITIONAL APPROPRIATION ORDINANCE FOR THE CITY OF MUNCIE

WHEREAS, Common Council passed Ordinance 21-18 fixing the maximum salaries of each and every appointed officer, employee, deputy, assistant, departmental and institutional head of the City of Muncie, Indiana; and

WHEREAS, Common Council passed Resolution 10-19 authorizing Mayor Dennis Tyler to Receive Indiana Housing & Community Development Authority Lead Hazard Reduction Demonstration Grant and Healthy Homes Supplemental Funding for Muncie, Indiana; and

WHEREAS, additional staff in the Office of Community Development is needed in the position of Planner II in order administer additional,


