



ORDINANCE 49 -19

AN ORDINANCE CONCERNING REQUIRING AN ENVIRONMENTAL IMPACT STATEMENT AS A PREREQUISITE FOR CERTAIN ACTIONS BY THE COMMON COUNCIL OF THE CITY OF MUNCIE

WHEREAS, certain actions by the Common Council may have impact on environmental concerns and,

WHEREAS, the City of Muncie has established an Environmental Impact Committee to address concerns that the City of Muncie and its residents may have on certain proposed projects, and,

WHEREAS, the preparation of an environmental impact statement prior to consideration of certain matters by the Common Council would be beneficial to the Council and the Environmental Committee,

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, AS FOLLOWS:

1. That along with any Ordinance or Resolution requesting approval of any Tax Abatement for a period in excess of six years on real estate or any type of issuance of any revenue bonds pursuant to Ind. Code 36-7-11.9-1, et. seq. Ind. Code 36-7-12- 1, et. seq. (Economic Development and Pollution Control or 36-7-13-1, et. seq. (Industrial Development) in the City of Muncie there shall be filed with the city clerk an Environmental Impact statement which describes the proposed impact on the property and surrounding properties air quality, ground water impact and waterway quality impact.
2. The Environmental Impact statement should contain substantially the same information supplied to the Indiana Department of Environmental Management of Environmental Protection Agency in any application for any permit.
3. The Environmental Impact Statement must be compiled by a recognized by an independent environmental or engineering firm and the cost be born by the person or entity seeking the tax abatement of bond financing.

4. This Ordinance shall be in full force and effect upon passage by the Common Council and signature of the Mayor or override of his veto..
