


RESOLUTION NO. 18-19



**RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF MUNCIE
CENSURING LINDA GREGORY FOR A STATEMENT MADE DURING THE
SEPTEMBER 9, 2019 MEETING OF THE COMMON COUNCIL OF THE CITY OF
MUNCIE**

WHEREAS, during the Regular Meeting of the Common Council of the City of Muncie Councilperson Linda Gregory made a statement that many rightfully perceived as racially insensitive and offensive, and,

WHEREAS, Indiana Code 36-4-6-6 and Sec 32.06 of the City of Muncie Code of Ordinances grant the Common Council Council the authority to remove members and inherently, the authority to censure or otherwise reprimand tis members, and

WHEREAS, Councilperson Gregory failed to timely accept responsibility for the racially insensitive and offensive statement, and,

WHEREAS, such statements do not reflect the values of the Common Council, the City Administration and the residents of the City of Muncie.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Muncie, Indiana, as follows:

1.The Common Council of the City of Muncie, Indiana hereby Censures Councilperson Linda Gregory for her statement made during the September 9, 2019 as being racially insensitive and offensive.

2. That the Council recommends that Councilperson Linda Gregory, should she remain on the Council, not be placed on any standing Committees by the Council President for the 2020 calendar year.

3. This Censure shall be in full force and effect upon passage by the Common Council and signature of the Mayor or override of his veto..




