RESOLUTION NO. 20-19

**A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF MUNCIE,
INDIANA, APPROVING AN AMENDMENT TO THE DECLARATORY RESOLUTION
AND ECONOMIC DEVELOPMENT PLAN FOR THE CONSOLIDATED MUNCIE
ECONOMIC DEVELOPMENT AREA**

(CONSOLIDATED MUNCIE ALLOCATION AREA NO. 1)

WHEREAS, the City of Muncie Redevelopment Commission (the "Redevelopment Commission") previously adopted and amended a Declaratory Resolution (the "Declaratory Resolution") establishing the Consolidated Muncie Economic Development Area (the "Economic Development Area") and the Consolidated Muncie Allocation Area No. 1 ("Allocation Area No. 1") in the City, and approving an Economic Development Plan for the Economic Development Area (the "Plan"); and

WHEREAS, the Redevelopment Commission heretofore approved and adopted a Resolution (the "2019 Resolution") amending the Declaratory Resolution to provide for the removal of certain parcels as specified in the 2019 Resolution; and

WHEREAS, the Redevelopment Commission submitted the 2019 Resolution to the Delaware-Muncie Metropolitan Plan Commission (the "Plan Commission") for its approval pursuant to IC 36-7-14-16; and

WHEREAS, the Plan Commission heretofore issued its order approving the 2019 Resolution;

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of Muncie, Indiana, as follows:

1. The Common Council hereby approves the amendment to the Declaratory Resolution and the Plan as provided in the 2019 Resolution, and hereby approves the order of the Plan Commission approving the 2019 Resolution.
2. This Resolution shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor as required by law.
