AN ORDINANCE FOR ADDITIONAL APPROPRIATIONS (PARKS DEPARTMENT)

WHEREAS, it has been determined that it is now necessary to add additional appropriations to replace 2 older vehicles for the Muncie Parks Department.


AND

WHEREAS, it has been determined that the Parks Department has an unappropriated cash balance of \$870,077.66 as of 01/01/2020 that will fund these purchases.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

SECTION 1. The following additional sums of money are hereby appropriated, transferred, or reduced out of the funds named and for the purposes specified, subject to the laws governing the same. Fund 201 is the "Park Operating Fund" and Department 27 is titled "Park Department".
