



MUNCIE CITY COUNCIL
ORDINANCE 4 -20

TO AMEND SECTION 50.01 OF CHAPTER 50
OF THE MUNCIE CITY CODE ENTITLED "SANITARY DISTRICT ESTABLISHED."

WHEREAS, Section 50.01 of Chapter 50 of the Muncie City Code establishes the Muncie Sanitary District.

WHEREAS, Indiana law permits the appointment of a sanitary district board consisting of not less than three (3) commissioners but not more than five (5) commissioners; and

WHEREAS, Enlarging the existing board of sanitary commissioners from three to five members will provide better oversight and accountability for the sanitary district;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, DELAWARE COUNTY, INDIANA, THAT:

Section 1 Section 50.01 shall be amended to read by adding the following:

- (E) The sanitary district board shall consist of five (5) commissioners. All of the commissioners shall be appointed by the mayor, unless one of the commissioners is the city engineer, in which case the other four (4) commissioners shall be appointed by the mayor. Not more than three (3) of the commissioners shall be of the same political party.

Section 2 Transition.
The commissioners serving in office at the time of the adoption of this ordinance shall continue in office until the expiration of their current terms. One of the two commissioners taking office by virtue of this ordinance shall serve initially until December 31, 2021, and thereafter he or she or his or her successor shall serve for terms of four (4) years. The other of the two commissioners taking office by virtue of this ordinance shall serve until December 31, 2023, and thereafter he or she or his or her successor shall serve for terms of four (4) years.

Section 2 Effective Date.
This ordinance shall become effective on the date of passage.
