Ordinance 8-20

**AN ORDINANCE OF THE CITY OF MUNCIE TO
 TRANSFER FUNDS (GENERAL FUND – POLICE / FIRE MERIT COMMISSION)**

WHEREAS, it has been determined that the City Council approved to create separate and distinct line items for The City of Muncie Fire Department Merit Commission and The City of Muncie Police Department Merit Commission through Ordinance 5-20;

AND

WHEREAS, it has been determined that the controller has renamed department “16-Merit Commission” to “16-Police Merit Commission” and created department “25-Fire Merit Commission”.

AND

WHEREAS, it has been determined that The City of Muncie Fire Department Merit Commission and The City of Muncie Police Department Merit Commission have agreed to split the total Merit Commission budget equally.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

SECTION 1. The sum of Seventeen Thousand Two Hundred and Ninety-Five Dollars (\$17,295) be transferred from department 16-Police Merit Commission to 25-Fire Merit Commission as outlined below.
