**ORDINANCE NO. 9 -20**

**AN ORDINANCE OF THE CITY OF MUNCIE AMENDING SECTION 32.33  
OF THE CITY OF MUNCIE CODE OF ORDINANCES**

WHEREAS, Section 32.33 of the City of Muncie Code of Ordinances sets forth the time and place of regular meetings of the Common Council of the City of Muncie; and

WHEREAS, Section 32.33 provides that regular meetings of the Common Council shall commence at 7:30 p.m. on the first Monday of each month; and

WHEREAS, Section 32.33 has not been updated since 1980 and references a repealed section of the Indiana Code governing the date of the first regular meeting of the Common Council after an election; and

WHEREAS, the Common Council desires to update the outdated statutory reference, move the start time of regular meetings to 7:00 p.m. to allow for meetings to conclude earlier in the evening and clarify the standard location of all regular meetings.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, DELAWARE COUNTY, INDIANA, THAT:**

**Section 1:** Section 32.33 of the City of Muncie Code of Ordinances shall be amended to read as follows:

The first regular meeting of the council shall be held on the first Monday in January at 7:00 p.m. following its election as required by Ind. Code § 36-4-6-7(a). Thereafter, all regular meetings of the council shall be held on the first Monday evening of each month at 7:00 p.m. and may be adjourned at the pleasure of the council. Adjourned meetings shall have all the force and effect of regular meetings. All regular meetings of the council shall be held in the City Hall auditorium, unless otherwise determined by the President and designated on the agenda and set forth in a properly posted notice to the public.

**Section 2:** This ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor of the City of Muncie.
