Notice is hereby given to taxpayers of **MUNCIE CIVIL CITY, Delaware County, Indiana** that the proper officers of **MUNCIE CIVIL CITY** at **CITY AUDITORIUM AT 300 N. HIGH ST** on **Tuesday, September 04, 2012** at **07:30 PM** will conduct a public hearing on the year **2013** budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objection petition with the proper officers of **MUNCIE CIVIL CITY** within seven days after the hearing. The objection petition must identify the provisions of the budget, tax rate, or tax levy that taxpayers object to. If a petition is filed, the **MUNCIE CIVIL CITY** shall adopt with its budget a finding concerning the objections filed and testimony presented. Following the aforementioned hearing, the **MUNCIE CIVIL CITY** will meet at **CITY AUDITORIUM AT 300 N. HIGH ST.** on **Monday, October 01, 2012** at **07:30 PM** to adopt the following budget:
