Pursuant to CARES Act waivers the admin budget for PY 2019 HOME program will increase by \$71,830 (From 10% to 20%). Several public service agencies did not expend the full amount of their 2019 CDBG grant and those funds are being reallocated to Whitely Community Council (thus the 2020 CDBG \$8,800 cancellation). CDBG-CV (CARES Act) funds will be used to fund City Hall ADA accessible doors instead of paving and sidewalks. CDBG-CV3 (CARES Act) allocation will partially pay the Marriott Hotel bond. All substantial changes to 2019, 2020 HOME; 2019, 2020 CDBG; CDBG-CV and CDBG-CV3 budgets are summarized below.
